DEFINED TERMS

The following definitions shall apply to and are used in this Request for Proposals:

- "Applicable Law" means any statute, law, constitution, charter, ordinance, resolution, judgment, order, decree, rule, regulation, directive, standard or similarly binding authority, which shall be enacted, adopted, promulgated, issued or enforced by a governmental body relating to the Commission, the Selected Respondent or the performance of the Services.
- "Commission" or "NJDWSC" refers to the North Jersey District Water Supply Commission.
- "<u>RFP</u>" refers to this Request for Proposals, including any amendments thereof or supplements thereto.
- "<u>Proposal</u>" refers to the complete response to this RFP, submitted by a Respondent.
- "Owner's Representative" The designated official representative of the Commission to oversee the project.
- "Engineer" Commission Engineering Staff.
- "Respondent" or "Respondents" refers to the interested person(s) and/or firm(s) that submit a Proposal.
- "<u>Selected Respondent</u>" refers to the Qualified Respondent selected by the Commission for the award of a Contract to perform the Services.
- "Contract" refers to this RFP, the subsequent contract to be entered into with the Selected Respondent, which shall incorporate this RFP, and any addendums or clarifications.
- "<u>Contractor</u>" as referenced in Section 1.8 of this RFP, refers to the Selected Respondent.
- "Services" refers to the services to be provided by the Selected Respondent for the provision of **Professional Land Surveying Services for Commission-owned Dams** in accordance with the provisions of this RFP and the Contract to be prepared by the Commission.
- "NJDEP" New Jersey Department of Environmental Protection

INTRODUCTION AND GENERAL INFORMATION

1.1. <u>Introduction and Purpose</u>.

The Commission is organized and exists under and pursuant to N.J.S.A. 58:5-1 et seq., and is a public body politic and corporate formed by its member municipalities and authorized to acquire, develop and operate a water supply system for use by any municipality in the Counties of Sussex, Warren, Hunterdon, Passaic, Morris, Monmouth, Somerset, Bergen, Hudson, Essex, Union and Middlesex (the "District"). Pursuant to its enabling legislation, the Commission is authorized to finance, construct and place into operation, and operate and use facilities deemed necessary for and incidental to the treatment, filtration, transmission and distribution of potable water for the benefit of municipalities within the District. The Commission presently contracts with municipalities, regional municipal purveyors, and publicly and privately-owned utilities. It is operated on a non-profit basis and funded through the municipalities and utilities that are contract participants of the Commission.

Through its Wanaque North and South projects, the Commission provides potable water to numerous contracting municipalities. In addition, the Wanaque South Project includes a joint venture between the Commission and Suez Water – New Jersey.

The Commission is soliciting Proposals for work associated with **Professional Land Surveying Services for Commission-owned Dams** as referenced in <u>Section 2, Scope of Services</u>. Through the procurement process initiated by this RFP, firms interested in assisting the Commission with the provision of such Services must prepare and submit a Proposal in accordance with the procedure and schedule established in this RFP. The Commission will review Proposals only from those firms that submit a Proposal that includes all of the information required to be submitted as described herein (in the sole judgment of the Commission).

1.2. <u>Procurement Process and Schedule.</u>

The Commission has structured a competitive process in order to ensure that each firm is provided an equal opportunity to submit a Proposal in response to the RFP. Proposals will be evaluated in accordance with the criteria set forth in Section 5 of this RFP, which will be applied in the same manner to each Proposal received.

The award of a contract to the Selected Respondent is subject to P.L. 2005, c. 51 (Chapter 51), codified at N.J.S.A. 19:44A-20.13 et seq., and Executive Order 117 (2008) (commonly known as pay to play limitations) and the New Jersey Election Law Enforcement Commission disclosure requirements set forth in P.L. 2005, C. 271, as amended, codified at N.J.S.A. 19:44A-20.26, and as more fully described in Section 1.8 of this RFP. Respondents, as part of this procurement process, and if selected, must at all times abide by all requirements of New Jersey law, and all relevant Executive Orders.

Proposals will be reviewed and evaluated by a Commission-established "Evaluation Committee" to determine if each Respondent has met the required professional and administrative requirements set forth in this RFP. Under no circumstances will a member of the Evaluation Committee review responses to an RFP for services for which they or their firm submitted a response hereunder. Based upon the totality of the information contained in the Proposal, including information about the reputation and experience of each Respondent, the Commission will, in its sole judgment, determine which Respondents are qualified from professional, administrative, and financial standpoints. Each Respondent who meets the requirements of the RFP, in the sole judgment of the Commission, will be designated as a Qualified Respondent and, from that pool of Qualified Respondents the Commission will then choose the Selected Respondent.

The procurement process commences with the issuance of this RFP. The steps involved in the process and the anticipated completion dates are set forth in Table 1, Anticipated Procurement Schedule. The Commission reserves the right to amend, modify, or alter the Procurement Schedule upon notice to all potential Respondents.

All Respondents shall be required to execute a Confidentiality & Non- Disclosure Agreement ("NDA") with the Commission for all information utilized <u>and</u> generated as part of this Contract. The NDA must be executed and returned to the Commission prior to the distribution of any and all documentation, drawings, models, etc., required for the preparation of a Proposal in response to this RFP. The NDA shall extend, if applicable, to the Respondent's subconsultants. A sample NDA is attached hereto as **Attachment # 2**.

All communications concerning this RFP or the RFP process shall be directed to the Commission's designated contact person, Margaret Maddalena, Contract Administrator, in writing and e-mail to mmaddalena@njdwsc.com. In order to maintain the integrity of the procurement process, it is requested that all communications concerning the RFP or RFP process be made in writing.

Proposals will not be accepted by facsimile transmission or e-mail. Please indicate on the outside of the sealed envelope, "Response to Request for Proposals for Professional Land Surveying Services for Commission-Owned Dams "RFP #002-2022".

Subsequent to issuance of this RFP, the Commission (through the issuance of addenda to all firms that have received a copy of the RFP) may modify, supplement or amend the provisions of this RFP in order to respond to inquiries received from prospective Respondents or as otherwise deemed necessary or appropriate by, and in the sole judgment of, the Commission.

1.3. Conditions Applicable to RFP.

Upon submission of a Proposal in response to this RFP, the Respondent acknowledges and consents to the following conditions relative to the submission and review and consideration of its Proposal:

- All costs incurred by the Respondent in connection with responding to this RFP shall be borne solely by the Respondent.
- The Commission reserves the right, in its sole judgment, to reject for any reason, any and all Proposals, or components thereof, and to eliminate any and all Respondents responding to this RFP from further consideration.
- The Commission reserves the right, in its sole judgment, to reject any Proposal that includes incomplete responses to the RFP, to reject any Proposal that contains exceptions to the requirements of this RFP, or to reject a Proposal that is not responsive to the requirements of this RFP.
- The Commission reserves the right, without prior notice, to supplement, amend, or otherwise modify the terms of this RFP, or otherwise request additional information.
- All Proposals shall become the property of the Commission upon submission and will not be returned.
- All Proposals will be made available to the public at the appropriate time, as determined by the Commission in its sole discretion, and in accordance with Applicable Law.
- The Commission may request certain Respondents send representatives to the Commission for interviews.
- Any and all Proposals not received by the Commission by 1:30 PM, Prevailing Time, on <u>Thursday, May 5, 2022</u> will be rejected.
- Neither the Commission, nor its respective Commissioners, staff, consultants, nor advisors (including but not limited to the Evaluation Committee), shall be liable for any claims or damages resulting from the solicitation or preparation of any Respondent's Proposals, nor will there be any reimbursement to Respondents for the cost of preparing and submitting a Proposal or for participating herein.

1.4. Rights of Commission.

The Commission reserves, holds and may exercise, in its sole discretion, the following rights and options with regard to this RFP and the procurement process in accordance with Applicable Law:

- To determine that any Proposal received complies or fails to comply with the terms of this RFP.
- To change or alter the schedule for any events called for in this RFP upon the issuance of notice to all prospective Respondents who have received a copy of this RFP.
- To conduct investigations of any or all of the Respondents, as the Commission deems necessary or appropriate, to clarify the information provided as part of the Proposal and to request additional information to support the information included in any Proposal.
- To request that Respondents send representatives to the Commission for interviews at a time and place designated by the Commission.
- To request additional information from prospective Respondents.
- To cancel this RFP or procurement process if it determines it is in the Commission's or the public interest to do so and to institute another procurement process.
- To reject any Respondent that submits in response to this RFP a Proposal that is incomplete or not responsive to the requirements of this RFP.
- To reject any Proposal as non-responsive, to the extent permitted by Applicable Law, that takes any exception or makes any additions to any term or condition of the RFP (including the Proposal forms in the Appendices).
- To request clarification or amplification from any Respondent regarding its Proposal, or any portion thereof.
- To request an oral presentation with certain Respondents, if it believes that it would be helpful to the Commission or Evaluation Committee to do so.
- To negotiate with one or more Respondents after receipt of Proposals on any of the final terms and conditions of the retention, including price, so long as the Commission maintains a written record of all such negotiations.
- To reserve the right to not select any Selected Respondent(s) for final contract award as a result of the RFP process.
- To reserve the right to waive minor irregularities. The Commission also reserves the right to waive a mandatory requirement provided that:

- 1. the requirement is not mandated by law;
- 2. all of the otherwise responsive Proposals failed to meet the mandatory requirement; or
- 3. in the sole discretion of the Commission, the failure to comply with the mandatory requirement does not materially affect the procurement or the Commission's interests associated with the procurement.

1.5. Addenda or Amendments to RFP.

During the period provided for the preparation of responses to the RFP, the Commission may issue addenda, amendments, or answers to written inquiries. Those addenda will be noticed by the Commission and will constitute a part of the RFP. All responses to the RFP shall be prepared with full consideration of the addenda issued prior to the submission date for the Proposal.

1.6. <u>Cost of Proposal Preparation</u>.

Each Proposal shall contain all information required to be submitted pursuant to the RFP and shall be prepared at the sole cost and expense of the Respondent. The Respondent agrees that it will not seek reimbursement from the Commission, its Commissioners, staff, or consultants for the costs or expenses incurred in the submission of a Proposal.

1.7. Proposal Format.

Proposals should cover all information requested in this RFP. Proposals that, in the sole judgment of the Commission, fail to meet the requirements of the RFP or are in any way conditional, incomplete, obscure, contain additions or deletions from requested information, or contain errors, may be rejected.

1.8. Campaign Contributions and Expenditure Reporting.

In order to safeguard the integrity of the Commission's procurement process, the Commission has imposed restrictions to insulate the award of contracts from political contributions that pose the risk of improper influence, purchase of access, or the appearance thereof. The terms and conditions set forth in this Section are material terms of any contract resulting from this RFP.

a. <u>Definitions</u>. For the purposes of this Section, the following shall be defined as follows:

- (i) Contribution means a contribution reportable as a recipient under "The New Jersey Campaign Contributions and Expenditures Reporting Act" N.J.S.A. 19:44A-1 et seq., and implementing regulations set forth at N.J.A.C. 19:25-7 and N.J.A.C. 19:25-10.1 et seq. Currently, contributions in excess of \$300 during a reporting period are deemed "reportable" under these laws.
- (ii) Contractor means any natural or legal person, business corporation, professional service corporation, limited liability company, partnership, limited partnership, business trust, association or any other legal commercial entity organized under the laws of New Jersey or any other state or foreign jurisdiction. It also includes (a) all principals who own or control more than 10 percent of the profits or assets of a Contractor or 10 percent of the stock in the case of a Contractor that is a corporation for profit, as appropriate; (b) any subsidiaries directly or indirectly controlled by the Contractor; (c) any political organization organized under 26 <u>U.S.C.</u> 527 that is directly or indirectly controlled by the Contractor, other than a candidate committee, election fund, or political party committee; and (d) if a Contractor is a natural person, that person's spouse or child, residing in the same household.

b. Breach of Contract.

It shall be a breach of the terms of any contract for the Contractor to (i) make or solicit a contribution in violation of the terms of this Section, (ii) knowingly conceal or misrepresent a contribution given or received; (iii) make or solicit contributions through intermediaries for the purpose of concealing or misrepresenting the source of the contribution; (iv) make or solicit any contribution

on the condition or with the agreement that it will be contributed to a campaign committee or any candidate of holder of the public office of Governor, or to any State or county party committee; (v) engage or employ a lobbyist or consultant with the intent or understanding that such lobbyist or consultant would subject that entity to the restrictions of this section; (vi) fund contributions made by third parties, including consultants, attorneys, family members, and employees; (vii) engage in any exchange of contributions to circumvent the intent of this Section; or (viii) directly or indirectly through or by any other person or means, do any act which would subject that entity to the restrictions of this Section.

c. Certification and Disclosure Requirements.

(i) The Commission is prohibited from entering into a contract with any Contractor for services or any material, supplies or equipment, or to acquire, sell or lease any land or building, where the value of the transaction exceeds \$17,500, if that Contractor has solicited or made any contribution of money, or pledge of contribution, including inkind contributions to a candidate committee and/or election fund of any candidate for or

holder of the public office of Governor, or to any State or county political party committee: (1) within the eighteen months immediately preceding the commencement of negotiations for the contract or agreement; (2) during the term of office of a Governor, in the case of contributions to a candidate committee or election fund of the holder of that office, or to any State or county political party committee of a political party nominating such Governor in the last gubernatorial election preceding the commencement of such term; or (3) within the eighteen months immediately preceding the last day of the term of office of Governor, in which case such prohibition shall continue through the end of the next immediately following term of the office of Governor, in the case of contributions to a candidate committee or election fund of the holder of that office, or to any State or county political party committee of a political party nominating such Governor in the last gubernatorial election preceding the commencement of the latter term. Effective November 15, 2008, Executive Order No. 117 extends the above prohibition to contributions made to a candidate committee or election fund of any candidate for or holder of the office of Lieutenant Governor, and to contributions made to a leaislative leadership committee or a municipal political party committee.

(ii) At the time of the submission of its Proposal, a Contractor shall report all contributions the Contractor made during the preceding four (4) years to any political organization organized under 26 <u>U.S.C.</u> 527 of the Internal Revenue Code that also meets the definition of a "continuing political committee" within the meaning of <u>N.J.S.A.</u> 19:44A-3(n) and <u>N.J.A.C.</u> 19:25-1.7. The required forms and instructions are included in this RFP package (see Attachment #3) and must be returned with a Contractor's Proposal fully complete. Failure to submit the fully completed "Two-Year Vendor Certification and Disclosure of Political Contributions" Chapter 51 Form with a Proposal, may result in the rejection of the Proposal, as well as preclude future contract opportunities in the sole judgment of the Commission.

(iii) Further, the Contractor is required, on a continuing basis, to report any contributions it makes during the term of the Contract, and any extension(s) thereof, at the time any such contribution is made. The required form and instructions are available for review on the Purchase Bureau website at http://www.state.nj.us/treasury/purchase/forms.shtml and shall be provided to the intended awardee with the Notice of Intent to Award.

d. Disclosure Review.

The Commission shall ensure that the disclosures submitted pursuant to this Section, as well as any other pertinent information concerning the contributions or reports thereof by the intended awardee, prior to award, or during the term of the Contract, by the Contractor are reviewed by the appropriate authorities. If it is determined that any contribution or action by the Contractor constitutes a breach of contract that poses a conflict of interest in the awarding of the contract under this solicitation, the Commission shall disqualify the Contractor from award of such contract.

1.9 Requirements of Executive Order #37.

On September 25, 2006, Governor Corzine signed Executive Order #37, which sets forth a series of reforms concerning the State's independent authorities. This RFP process shall at all times comply with the provisions of E.O. #37 requiring a "fair and transparent process." The Commission has established a scoring process and an Evaluation Committee pursuant to EO #37 and will be using both when determining which firm(s) to award a contract to. The factors that the Commission will use as part of this scoring process may include, but are not limited to, the following:

- a. The background, qualifications, skills, and experience of the firm and its staff;
- b. The firm's degree of expertise concerning the area at issue;
- c. The rate or price to be charged by the firm;
- d. The Commission's prior experiences with the firm;
- e. The firm's familiarity with the work, requirements, and systems of the State authority;
- f. The firm's proposed approach to the scope of work set forth in the project description or specifications;
- g. The firm's capacity to meet the requirements of the project at issue;
- h. The firm's references;
- i. Interviews with prospective firms; and
- j. Geographical location of the firm's offices.

Respondents are directed to **Section 5 of this RFP** for a complete description of the criteria to be utilized by the Commission in reviewing and evaluating each Proposal.

Section 2 of the RFP describes the **Scope of Services** to be performed by the Selected Respondent during the term of the Contract. As part of the criteria that the Evaluation Committee and the Commission will use to assess the Proposals submitted in response to the RFP, Respondents are required to demonstrate their qualifications and experience in providing these Services, and to describe their experience in performing these Services under similar contracts.

Should an oral presentation be requested by the Commission, it will be an opportunity for the Respondent to introduce its staff to the Commission, and to present supplementary information regarding its Proposal and credentials, as related to the specific needs of the Commission. The Respondent may use materials during this oral presentation; provided, however, that the presentation will be restricted to a maximum time period specified by the Commission, including the time allotted for a question and answer period. Information relating to the Respondent's recent experience on similar Professional Land Surveying Services for Commission-owned Dams

assignments, approach to the work and the use of innovative and/or cost effective measures should be included in the oral presentation.

END OF SECTION 1

SCOPE OF SERVICES

2.1. Project Overview.

It is the intent of the Commission to solicit Proposals from Professional Land Surveyors licensed to perform work in the State of New Jersey who have expertise in the principles and practices of land surveying as it relates to installing and surveying monuments, as well as to prepare drawings of current conditions with topography for the Commission's dams. The professional surveying services shall be in compliance with NJ Dam Safety Regulations and in accordance with the Operations and Maintenance procedures set forth by the DEP and Commission. The selected Firm shall be certified to perform professional land surveying services in the State of New Jersey and all paperwork, including measurements and drawings, shall be signed and sealed by a New Jersey Licensed Land Surveyor. Firms and/or persons responding to this RFP shall be able to demonstrate that they have the continuing capabilities to perform these services.

2.2. Scope of Services.

The Commission requires the services of a Professional Land Surveyor to provide the following services. A listing of the status of each of the dams and Overflow Weir is included in Section 2.4 Status of Dams.

TASK 1: Locate existing monuments on or adjacent to Commission-owned dams and resurvey these existing monuments, as well as reestablish the original missing or damaged monuments. The dams include Green Swamp Dams No. 1, 2, 2a, 3, 4, Wolf Den Dam, Midvale Dam, Furnace Dam, Raymond Dam and the associated Overflow Weir, and Monksville Dam.

- Originally, there were 57 surveying monuments on or adjacent to 10 Commission owned dams. Several of the monuments have been destroyed or cannot be found and need to be reestablished and surveyed. All existing monuments are to be resurveyed and marked. All missing monuments shall be located and/or re-installed and compared to the 2016 survey data. The 2016 data included for each monument list the following parameters:
 - 1. Location (name of dam)
 - 2. Point or Monument Number
 - 3. Ground Northing (to the hundredth)
 - 4. Ground Easting (to the hundredth)
 - 5. NAD 83-96 Northing (to the hundredth)
 - 6. NAD 83-96 Easting (to the hundredth)
 - 7. NAVD 88 Elevation (to the hundredth)

8. Description, i.e., TR Disk, Brass plug, rebar, etc.

All new monuments are to be surveyed and included with the pertinent survey data to compare with future monitoring of the monuments. Assume, for pricing purposes, that eighteen (18) new re-established monuments will be required.

TASK 2: Update monuments on one (1) Wanaque Dam.

Reservoir

 The Commission would like to update monuments atop the concrete core wall extensions of Green Swamp Dam No. 3. A monument should be established at either end of the core wall and should correspond with stationing as shown on the Record Drawings for the dam.

TASK 3: Establish stations on Wanaque Reservoir dams.

• Review existing Record Drawings of the dams. From these drawings establish stationing every 100 feet along any of the dams that do not currently have stationing. This can be done in conjunction with the new monuments on the core wall extension as mentioned in Task 2. This would be for Green Swamp Dam No. 3, and other dams not specifically mentioned that may need updating. This can be a "PK" installed in the top of the core wall extension or on the upstream masonry wall of Raymond Dam.

TASK 4: Preparation of drawings for ten (10) Wanaque Reservoir dams and Monksville Dam including plans with topography as well as a typical cross-section.

Provide an updated plan with topography of the current conditions and a typical cross-section of the dams. This will be required for Green Swamp Dams No. 1, No. 2, No. 2a, No. 3, No. 4, Wolf Den Dam, Raymond Dam, Midvale Dam, Furnace Road Dam, Overflow Weir, and Monksville Dam.

NOTE: Include prices for each of the separate Tasks listed above and a total Not-to-Exceed Price to provide all services required, as detailed within Tasks 1, 2, 3 and 4 including all expenses. The Commission reserves the right not to have certain tasks done for any reason and selected firm will be compensated <u>ONLY</u> for the tasks above that are done.

2.3. Access to Sites.

 Access to the furthest south-westerly dam (Green Swamp Dam No. 1) is via 2 miles of crushed stone roadways from the Commission's Facility at F.A. Orechio Drive, Wanaque, N.J.

- Access to Midvale Dam is via both paved and crushed stone access roads, approximately 1.3 miles from the Commission's entrance at 741 Ringwood Avenue, Wanaque, NJ.
- Access to Raymond Dam is through the Commission's Headworks entrance, located at 741 Ringwood Access to Furnace Road Dam is through a locked gate located near the intersection of West Brook Road and Greenwood Lake Turnpike (County Road 511). This is approximately 2.2 miles on traveling north on Ringwood Avenue, County Road 511 from the Commission Orechio Drive Facility in Wanaque, N.J.
- Monksville Dam is located approximately 7.5 miles from the Commission's Facilities in Wanaque. Directions are Ringwood Avenue (County Road 511) which turns into Greenwood Lake Turnpike to Stonetown Road, Ringwood, N.J.
- Access to Commission Dams are through locked gates and guard rail gates. It is
 important that all gates are locked at the end of the work day. When working onsite, the selected firm is to lock the gate so no unauthorized persons can enter
 Commission property while the firm is performing the work. The selected firm <u>MUST</u>
 <u>NOTIFY</u> the Commission's Security Headquarters at the end of each work day when
 firm is leaving site for the day.
- Traffic Control: Selected firm <u>MUST</u> contact Ringwood Police Department to discuss surveying work along the crest of Monksville Dam (which is also a public roadway). Any and all expenses associated with traffic control will be paid for by selected firm and be within price of proposal.

2.4. Status of Dams.

The following list Commission indicates the current status of surveying monuments on Commission-owned dams.

Green Swamp Dam No. 1:

- 630 foot long earthfill dam with concrete core wall extension. 2 existing monuments located off the dam, 3 monuments located on the dam.
- All 5 monuments/pk's must be located.
- Drawing showing current conditions with topography and a typical cross section of this dam is requested, said drawings to be signed and sealed by a NJ Licensed Land Surveyor.
- Re-establish monuments not found/missing on the corewall extension as well as off the dam.
- Stationing monuments to be re-installed on the corewall extension.

Green Swamp Dam No. 2:

- Concrete gravity dam, 1,150 feet long, locate 2 existing monuments located off the damas well as 7 monuments located on the concrete crest of dam.
- o All monuments/pk's must be located.

- o No additional monuments need to be added.
- An embankment (thermoblanket of water treatment plant residuals) has been constructed immediately downstream of this dam. A drawing showing current conditions with topography and a typical cross section for this dam is requested, including the dam itself, downstream thermoblanket construction, downstream roadway and to base of downstream roadway slope.

Green Swamp Dam No. 2A:

- o Earthfill dam, 90 feet long (No Concrete Core Wall Extension).
- No monuments were ever recommended for this dam and none are recommended at this time.
- No Stationing monuments are needed.
- Drawing showing current conditions with topography and a typical cross section of this dam is requested, said drawings to be signed and sealed by a NJ Licensed Land Surveyor.

Green Swamp Dam No. 3:

- 130 foot long earthfill dam with concrete core wall extension. Stationing monuments are requested.
- Locate two (2) monuments that were established in 2016 on top of the core wall extension at both ends.
- o Stationing monuments to be installed on the corewall extension.
- Drawing showing current conditions with topography and a typical cross section of this dam is requested, said drawings to be signed and sealed by a NJ Licensed Land Surveyor.

Green Swamp Dam No. 4:

- Concrete gravity dam, 272 foot long, locate 2 monuments that are located off the dam, , one monument is located on a rock shelf 15 feet above the crest of the dam at the left abutment in prior surveys.
- Locate three (3) monuments which are within the concrete crest. Re-establish monuments not found/missing on concrete crest.

Wolf Den Dam:

- o Earthfill dam, 2,200 foot long with concrete core wall extension. Several monuments are located off the dam.
- o Locate twelve (12) monuments installed in 1999 on the dam. Re-establish monuments not found or that are missing.
- Drawing showing current conditions with topography and a typical cross section of this dam is requested, said drawings to be signed and sealed by a NJ Licensed Land Surveyor.

Professional Land Surveying Services for Commission-owned Dams

Overflow Weir:

- Concrete gravity dam structure, 552 foot feet long, locate 2 monuments that are located off the structure, 2 are located at the top of the spillway crest.
 Re-establish monuments not found or that are missing.
- o NOTE: If the Wanaque Reservoir Elevation is too high to perform required measurements, selected firm shall hold the price firm to perform the surveying work at this facility for one year from the issuance of the Notice to Proceed by the Commission. It will then be the Commission's responsibility to contact selected firm if and when the reservoir drops to an elevation when this structure can be resurveyed.

Raymond Dam:

o Earthfill dam, 1,600 foot long, with paved private roadway on crest. 2 monuments are located within the corewall of the dam, said monuments accessible by removable 12" x 12" steel plates in roadway, box shall be cleaned and monuments exposed and re-established. Seven (7) monuments set in the pavement of the roadway traveling the crest of this dam. Reestablish monuments not found/missing on the corewall extension as well as off the dam.

Midvale Dam:

- Earthfill Dam, 950 foot long, with concrete core wall extension. One monument is located off the dam, 5 others are to be on the dam. Three (3) monuments were located as well as the reference monument off the dam. One (1) damaged concrete post was located with surveying disk missing. Two (2) monuments have not been located. Re-establish monuments not found/missing or damaged on the corewall extension as well as off the dam.
- Drawing showing current conditions with topography and a typical cross section of this dam is requested, said drawings to be signed and sealed by a NJ Licensed Land Surveyor.
- o Stationing markers are to be re-installed on this dam if necessary.

Furnace Road Dam:

Earthfill dam, 790 foot long, with an impervious core.Locate two (2) monuments that are located off the dam.. Three (3) monuments were installed in 1999 and shall be field located or re-established and resurveyed. Drawing showing current conditions with topography and a typical cross section of this dam is requested, said drawings to be signed and sealed by a NJ Licensed Land Surveyor.

Professional Land Surveying Services for Commission-owned Dams

Monksville Dam:

 Roller Compacted Concrete (RCC) Gravity Dam, 2200 foot long with a public roadway (Stonetown Road, Ringwood, NJ) traveling on crest. Fourteen (14) monuments were installed either on or adjacent to this dam in 1999. Reestablish monuments not found or that are missing or damaged on the dam.

2.5. <u>Insurance and Indemnification Requirements.</u>

The Selected Respondent shall fully indemnify, defend and hold harmless the Commission, the Commissioners, their members, directors, officers, agents, servants, employees and successors and assigns from and against all losses, fines, penalties, damages, lawsuits, claims, causes of action, liabilities, demands, obligations to Contractor, and expenses, including attorneys' fees in connection with the loss of life, personal injury, bodily injury, and/or property damage, if occasioned in whole or in part by any negligent act or omission of the Contractor or the Contractor's agent's, servants, employees, and subcontractors in the performance of services and provision of goods under this contract. This obligation shall include the provision of a defense for the Commission at all stages of the claims or judicial process and together with all losses, fines, penalties, costs and expenses relating to any of the foregoing, including but not limited to, court costs and reasonable attorneys' fees arising out of this Contract and to enforce this indemnification provision.

The Selected Respondent retained to perform the Services will be required to obtain and maintain continuously, at its own expense, and file with the Commission and its insurance broker evidence of coverage as enumerated below:

1. Commercial General Liability Insurance:

Commercial General Liability Insurance, written on an industry standard occurrence form (CG 00 01), 1207 Edition or Equivalent.

The Selected Respondent shall maintain Products Completed Operations liability coverage for a period of at least twenty-four (24) months following the Final Project Completion Date.

3. Worker's Compensation:

- Employer's Liability:

4. Excess/Umbrella Insurance:

Minimum Combined Limit of Liability: \$3,000,000 Each Incident

Definition of Covered Services: Includes all services performed by the insured for a fee.

The Selected Respondent shall maintain this Insurance for a period of at least twenty-four (24) months following the expiration of the contract term and/or termination of service.

The Commission must be named as an additional insured under all applicable policies (except for Worker's Compensation and Professional Liability) and the Selected Respondent must provide the Commission with current Certificates of

Acceptance by the Commission of deficient evidence of insurance does not constitute a waiver of contract requirement as provided by conditions of the contract.

2.6. Personnel.

The Selected Respondent represents and agrees that:

- 1. It has the personnel necessary to provide the Services as requested;
- 2. No personnel provided by the Selected Respondent are, or shall be, employees of the Commission, nor shall they have any contractual relationship with the Commission;
- 3. All of the Services to be provided by the Selected Respondent pursuant to this Agreement will be provided by personnel qualified to perform the particular work; and
- 4. None of the Services to be provided by the Selected Respondent shall be provided by any subconsultant, or under any subcontract for services, without the prior consent of the Commission. The Selected Respondent shall include within their proposal, the company name(s) of any anticipated subconsultant(s), along with the subconsultant's qualifications and work tasks to be performed by the subconsultant(s). Any and all work performed by a subconsultant is to be supervised by the Selected Respondent. Costs of any subcontractors are to be included within the Fee Proposal.

2.7. Confidentiality & Non-Disclosure Agreement

The Respondent shall hold in trust and not reveal to any third party, except as provided in this RFP and/or subsequent Contract, if applicable, between the Commission and the Selected Respondent(s) (referred to as the "Consultant" in this section), any and all confidential or "Security Related" information as defined herein. The Consultant shall require its employees and subconsultants to comply with the provisions of this RFP and/or subsequent Contract, if applicable, as it pertains to confidentiality. This Section must be included in all subcontracts entered into by the Consultant.

Confidential or "Security Related" information shall include:

- Any and all financial, statistical, personnel and/or technical data supplied to the Respondent or, as applicable, the Consultant.
- Any and all data, technical information, material gathered, generated, originated, developed, prepared, used or obtained in the performance of this Contract, including results and opinions of the Consultant.

 Any and all communications between the Commission and the Consultant, and the Consultant and any third party regarding the performance of this Contract.

The Consultant is required to protect the confidentiality of such data. Any use, copying, distribution, sale or offering of this data in any form by the Consultant, or any individual or entity in the Consultant's charge or employ for purposes not connected with this Contract, will be considered a violation of this Contract and may result in contract termination and the Consultant's suspension or debarment from State contracting. In addition, such conduct may be reported to the State Attorney General for criminal prosecution to the extent allowed by law.

It is further agreed that any information supplied by the Commission to the Consultant and any information developed by the Consultant in satisfaction of the Scope of Work within this Contract is subject to the following conditions and restrictions, not including the conditions and restrictions set forth in the NDA annexed hereto as **Attachment #2**:

- Information received from or developed for the Commission is to be used solely for the purpose(s) established in this Contract.
- The data confidentiality matters coming within this Contract shall continue beyond the completion of all work involved in this Contract, unless specifically waived in writing by the Commission.
- Any and all asset information received prior to the issuance of this RFP shall be considered confidential or "Security Related" information; however, other information that was already known to the Consultant prior to the issuance of this RFP, or any information that is or has become publicly available and is rightfully received by the Consultant, or any information that is approved by the Commission for the Consultant to release shall not be considered confidential.

The Consultant, within the content of its reports, shall interpret nothing contained herein to interfere with or impose any limitation on the expression of professional judgment nor shall it restrict disclosure required of the Consultant by State or Federal Law. Unless such disclosure is specifically exempt due to the provisions of State or Federal Law, resolution of either or both houses of legislature, a regulation promulgated under the authority of any statute or Executive Order of the Governor, an Executive Order of the Governor, and/or Rules of Court.

procedures for protecting the confidentiality of such data in accordance with this Section. Subconsultants, if they are to be used, must also submit their written procedures or must submit a written agreement to accept and use the procedures of the Consultant.

Such procedures should address, but not be limited to, the following factors:

- Conducting criminal history background checks for any individual scheduled to work in any detail relating to the Scope of Work within this Contract.
- 2. Deselecting an individual based on the results of a criminal history background check.
- 3. Reviewing and authenticating immigration credentials for any individual who is a non-U.S. citizen.
- 4. Limiting and/or prohibiting, consistent with Applicable Law, the distribution of personal information for those personnel deemed to have access to confidential information concerning this Contract including the limitation of access to databases containing individual names, home addresses and other personal information.
- 5. Ensuring that individuals are fully aware of the importance of vigilance and reporting suspicious activities and security breaches to corporate security (or equivalent) and for corporate security (or equivalent) to refer all such reported activities to law enforcement officials.
- 6. Controlling and storing documents/data (both paper and electronic).

Upon approval of the Commission, these procedures shall become part of the Contract and failure by the Consultant or subconsultant to comply with these procedures will be considered a violation of this Contract.

All Respondents shall be required to execute an NDA with the Commission, for all information utilized <u>and</u> generated as part of this Contract. The NDA must be returned to the Commission prior to the distribution of any and all documentation, drawings, models, etc., required for the preparation of the Proposal in response to this RFP. The NDA shall extend, if applicable, to the Respondent's subconsultants.

2.8. Work Hours.

All work on Commission property shall be performed between the hours of 7:00 AM and 4:00 PM, Monday through Friday, New Jersey State Holidays excepted, unless other arrangements are made in advance with, and approved by, the Commission.

2.9. <u>Time of Completion</u>.

The time of completion for the overall contract shall be 180 days from date of the issuance of the Notice to Proceed by the Commission.

2.10. Security.

- Anyone entering the grounds of the Commission MUST submit an Access Approval Form, (see Attachment #1), with copy of Photo ID at least two (2) business days before arrival on site.
- Any and all photographs, drawings, information related to this RFP, and Proposal, shall be classified as CONFIDENTIAL and will become the property of the Commission. No documents, photos and information as it relates to this RFP, the Proposal, and the Services, are to be disseminated by the Selected Respondent.
- Proof of background checks will be required for personnel working for the Selected Respondent who might have access to Commission information.
- Please note, a new Access Approval Form must be submitted to Security for every visit to the Commission. Access Approval Forms may be found in (Attachment "#1") of the RFP Package.

2.11. Fee Proposal.

Section 3 of the RFP describes in detail the submission requirements, qualifications and criteria for the fee proposal.

2.12. Payments.

Compensation shall be payable within sixty (60) days of receipt of invoices with the approval of the Commission and in accordance with the Commission's standard accounting policies and procedures.

2.13. Change Orders/Amendments.

Any work outside of the scope of service of this contract for which the Consultant seeks additional fees or compensation shall require a prior written authorization from the Commission. The Commission will not pay any additional fees for additional services based on verbal agreements or conversations with a Commission employee.

SECTION 3 SUBMISSION REQUIREMENTS

3.1 General Requirements.

The Proposal submitted by the Respondent must meet or exceed the professional, administrative and financial qualifications set forth in this Section 3 and shall incorporate the information requested below.

In addition to the information required as described below, a Respondent may submit supplemental information that it feels may be useful in evaluating its Proposal. Respondents are encouraged to be clear, factual, and concise in their presentation of information.

3.2. Administrative Information Requirements.

The Respondent shall, as part of its Proposal, provide the following information:

- 10. Whether the business organization is now or has been involved in any bankruptcy or re-organization proceedings in the last ten (10) years. If yes, please provide a written description of the circumstances underlying the bankruptcy proceedings and a copy of any legal rulings relevant thereto.
- 11. Respondent shall submit a copy of all appropriate federal and state licenses to perform the Services.
- 12. Respondent shall submit a copy of its Business Registration Certificate.
- 13. Respondent shall submit an executed Affidavit of Non-Collusion (see Appendix C).

3.3. Minimum Professional Qualification Requirements.

The Respondent shall submit a description of its overall experience in providing the Services sought in the RFP, and provide proof of all certifications necessary to perform such Services. All Respondents must have a minimum seven years experience in the provision of dam surveying services and provide appropriate documentation supporting said qualifications as part of their proposals.

3.4. Professional Information Requirements.

For purposes of the above, "immediate relative" means a spouse, parent, stepparent, brother, sister, child, stepchild, direct-line aunt or uncle, grandparent, grandchild, and in-laws by reason of relation. If none, so state.
- 9. Provide a fully loaded rate sheet, by title/function, for all personnel anticipated to perform Services under the Agreement.

3.5. Affirmative Action.

During the performance of the Services, the Selected Respondent must agree as follows:

a. CONFIDENTIALITY AND NONDISCLOSURE AGREEMENT

THIS CONFIDENTIALITY AND NONDISCLOSURE AGREEMENT (the "Agreement") is made and entered into as of this day of, 2020 by and between:			
THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION (hereinafter, the "Commission"), located at One F.A. Orechio Drive, Wanaque, New Jersey 07465; and			
WITNESSETH			
WHEREAS , pursuant to <u>N.J.S.A.</u> 58:5-1 <u>et seq.</u> , the Commission is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and			
WHEREAS , the Commission fulfills a vital role in maintaining, overseeing, and securing the operation of the largest regional water supply in the State of New Jersey, the safety and security of said operation constituting a critical Homeland Security concern; and			
WHEREAS, in order to facilitate the possibility of entering into a contract for goods and services, and in particular, the procurement process pertaining to			
Commission-Owned Facilities, and if entered into, the execution of such business relationship, the Commission may disclose certain non-public or proprietary information to (or the "Receiving Party") and its representatives; and			

WHEREAS, the Commission wishes to preserve the confidentiality and prevent the unauthorized disclosure and use of any such non-public or proprietary information disclosed to the Receiving Party and its representatives.

NOW THEREFORE, in consideration of the mutual promises, covenants, representations and warranties made in this Agreement, the receipt and sufficiency of which are hereby acknowledged by the parties, intending to be legally bound, hereby agree as follows:

- 1. "Information" means all non-public or proprietary information of the Commission disclosed in connection with this Agreement and shall include, but not be limited to, information regarding the Commission or its related entities' assets, liabilities, financial and other conditions, insurance, reinsurance, employees, consultants, operations, facilities, prospects, business plans, customer lists, or security arrangements. Information also includes any documents prepared by the Receiving Party that through the use of non-public proprietary Information that was provided to the Receiving Party by the Commission.
- 2. As a condition to receiving the Information which the Commission may furnish to the Receiving Party and its representatives or to which the Receiving Party and its representatives are afforded access, directly or indirectly, the Receiving Party and its representatives shall take all reasonable measures to avoid disclosure, dissemination or unauthorized use of Information, including, at a minimum, those measures that the Receiving Party takes to protect its own confidential information of a similar nature (provided that such measures are consistent with at least a reasonable degree of care).

3. Information does not include information that:

- a. Has been or becomes published or is now or in the future publicly available without breach of this Agreement or breach of a similar agreement by a third party or through no wrongful act of the receiving party or its representatives; or
- b. Is known to the Receiving Party prior to the time such information was acquired from the Commission under this Agreement as evidenced by the Receiving Party's contemporaneous written records; or
- c. Is independently developed and prepared by the Receiving Party not in reliance upon or reflecting any Information disclosed pursuant to this Agreement; or
- d. Subsequent to disclosure, is lawfully received from a third party having rights therein without restriction (to the best of the Receiving Party's knowledge) on the right of such third party or the Receiving Party to disseminate the information and without notice of any restriction against its further disclosure.
- 4. Information shall not, without the prior written consent of the Commission, be disclosed to any person or entity other than the Receiving Party's and its representatives' employees (including outside legal counsel, actuaries and accountants) who need to know the Information and in those instances only to the extent of such need. The Receiving Party agrees to keep all Information confidential, and further agrees to use Information

- solely for the evaluation stated above, and for no other purpose. The Receiving Party agrees that it and its representatives' employees (including outside legal counsel, actuaries and accountants) shall be informed of the terms of this Agreement.
- 5. All Information shall remain the exclusive property of the Commission, and the Receiving Party shall have no rights, by license or otherwise, to use Information except as expressly provided herein.
- 6. The Receiving Party agrees on its own behalf and on behalf of its representatives and/or assigns to return to the Commission or destroy, and verify in writing such destruction, all written, tangible or otherwise accessible material in any form (including electronic media such as computer diskettes, CD-ROM, electronic copies or any material resident in the hard or external drive of any computer) containing or reflecting any Information (including all copies, summaries, excerpts, extracts, notes or other reproductions) promptly at the request of the Commission or within sixty (60) days of the termination or conclusion of the parties' business or contractual relationship. All information retained by the Receiving Party pursuant to this Section 6 shall remain subject to the confidentiality and nondisclosure obligations of this Agreement. Notwithstanding anything to the contrary in this Agreement, the Receiving Party may retain one copy of Information that has become part of a file that the Receiving Party, in its reasonable judgment, is required to retain and/or make available for examination by government regulatory or investigatory agencies, or retain and/or produce by an order of a court or insurance regulatory agency.
- 7. Nothing in this Agreement shall impose any obligation upon either party to consummate a transaction, to enter into any discussion or negotiations with respect thereto, or to take any other action not expressly agreed to herein.
- 8. In the event that the Receiving Party receives a request to disclose all or any part of the Information as part of a governmental investigation or under the terms of a subpoena or order issued by a court or governmental body, the Receiving Party will take all reasonable steps to notify the Commission promptly in writing of such request in order to allow the Commission an opportunity to resist or narrow such request and will reasonably cooperate, at the Commission's expense, with the Commission and its representatives in connection with the Commission's efforts to resist or narrow such request. In the event that the Commission elects to waive the provisions of this Section 8 or is otherwise unsuccessful in resisting such request, the Receiving Party shall only disclose the Information that it determines it is legally required to disclose after consultation with competent counsel.
- 9. Except as required by applicable law or court or arbitral order, neither party shall in any way or in any form disclose (except as necessary to such party's outside legal counsel, actuaries and accountants), publicize or advertise in any manner the discussions or negotiations concerning the business purpose underlying this Agreement, or the status of any such discussions or negotiations without the consent of the other party.
- 10. This Agreement shall be deemed to be a contract made under the laws of the State of New Jersey and for all purposes shall be construed in accordance with the laws thereof.

The parties agree that any and all disputes between the parties under or relating to the terms and conditions of this Agreement shall be fully and completely adjudicated in the courts of the State of New Jersey.

- 11. Any provision of this Agreement which may be prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof or affecting the validity or enforceability of such provision in any other jurisdiction.
- 12. Neither this Agreement nor any rights or obligations hereunder may be assigned by either party hereto without the prior written consent of the other party, and such consent shall not be unreasonably withheld, delayed or conditioned. This Agreement shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns. No permitted assignment shall relieve a party of its obligations hereunder with respect to Information disclosed prior to the assignment. Any assignment in violation of this Paragraph Thirteen (12) shall be deemed null and void.
- 13. No amendment to any provision of this Agreement shall be binding and enforceable unless in writing and signed by both of the parties and specifically referencing this Agreement.
- 14. This Agreement shall continue to be binding after the conclusion of the business or contractual relationship between the parties absent prior written consent of both parties.
- 15. This Agreement shall not be interpreted in a manner that would violate any applicable cannons of ethics or codes of professional responsibility. Nothing in this Agreement shall prohibit or interfere with the ability of counsel for any party to represent any individual, corporation, or other entity adverse to any party or its affiliate(s) in connection with any other matters.
- 16. Each of the parties acknowledges and agrees that remedies at law may be inadequate to protect the Commission against any actual or threatened breach of this Agreement by the Receiving Party or its representatives, and, without prejudice to any other rights and remedies otherwise available to the Commission (including, without limitation, monetary damages), the Receiving Party agrees to the granting of specific performance and injunctive or other equitable relief in the Commission's favor without proof of actual damages and each of the parties further agrees to waive, and to use all reasonable efforts to cause its representatives to waive, any requirement for the securing or posting of any bond in connection with any such remedy. Nothing in this Agreement shall be deemed or construed to limit or prevent the Commission from bringing a claim for damages as a result of any actual or threatened breach of this Agreement by the Receiving Party or its representatives.
- 17. Each of the parties agrees that no failure or delay by the Commission in exercising any right or remedy hereunder will operate as a waiver thereof, nor will any single or partial exercise thereof preclude any other or further exercise of any right or remedy hereunder.

- 18. This Agreement was entered into solely to benefit the parties and no other person or entity shall have enforceable rights and remedies hereunder or hereby.
- 19. This Agreement may be executed in one or more counterparts (including via facsimile), each of which shall be deemed an original but all of which together shall constitute one in the same instrument.

INFORMATION AND INSTRUCTIONS

For Completing the "Two-Year Vendor Certification and Disclosure of Political Contributions" Chapter 51 Form

Background Information

On September 22, 2004, then-Governor James E. McGreevey issued E.O. 134, the purpose of which was to insulate the negotiation and award of State contracts from political contributions that posed a risk of improper influence, purchase of access or the appearance thereof. To this end, E.O. 134 prohibited State departments, agencies and authorities from entering into contracts exceeding \$17,500 with individuals or entities that made certain political contributions. E.O. 134 was superseded by Public Law 2005, c. 51, signed into law on March 22, 2005 ("Chapter 51").

On September 24, 2008, Governor Jon S. Corzine issued E.O. 117 which is designed to enhance New Jersey's efforts to protect the integrity of procurement decisions and increase the public's confidence in government. The Executive Order builds upon the provisions of Chapter 51.

Two-Year Certification Process

Upon approval by the State Chapter 51 Review Unit, the Certification and Disclosure of Political Contributions form is valid for a two (2) year period. Thus, if a vendor receives approval on January 1, 2014, the certification expiration date would be December 31, 2015. Any change in the vendor's ownership status and/or political contributions during the two-year period will require the submission of new Chapter 51/Executive Order 117 forms to the State Review Unit. Please note that it is the vendor's responsibility to file new forms with the State should these changes occur.

State Agency Instructions: Prior to the awarding of a contract, the State Agency should first use NJSTART (https://www.njstart.gov/bso/) to check the status of a vendor's Chapter 51 certification before contacting the Review Unit's mailbox at CD134@treas.nj.gov. If the State Agency does not find any Chapter 51 Certification information in NJSTART and/or the vendor is not registered in NJSTART, then the State Agency should send an e-mail to CD134@treas.nj.gov to verify the certification status of the vendor. If the response is that the vendor is NOT within an approved two-year period, then forms must be obtained from the vendor and forwarded for review. If the response is that the vendor is within an approved two-year period, then the response so stating should be placed with the bid/contract documentation for the subject project.

Part 2: DISCLOSURE OF CONTRIBUTIONS

Read the three types of political contributions that require disclosure and, if applicable, provide the recipient's information. The definition of "Business Entity/Vendor" and "Contribution" can be found on pages 3 and 4 of this form

Name of Recipient - Enter the full legal name of the recipient.
